At Raketspel AB we respect your right to privacy and we are committed to providing both visitors to our sites and advertisers with the utmost in privacy and security. We understand that visitors to Shockplay.com need to control the uses of their personal information. We abide by all industry guidelines and the privacy policy below details the measures taken by Raketspel AB to protect your privacy in connection with your use of www.shockplay.com. Shockplay.com is a "member's only" games site, and in order to become a member you have to disclose personally identifiable information. Raketspel AB gathers user information to provide you with a customized experience on our site. Your user information helps us tailor the content, services, goods and advertising to your current and future needs.

1. The Information we collect

Raketspel AB collects personally identifiable information as part of the member registration process. Our site's order form requires users to give us delivery information (to include name, postal address, ZIP or postal code, country location, date of birth, gender, and e-mail address) and credit card information. We use customer details to bill the user for the service ordered at the site and to deliver the service to the user. The information is kept on a secure server to protect it from outside parties. We treat our customer data as strictly confidential and we do not sell it to, or share it with, any third parties. If we need users to clarify something with regards to orders, we will contact users by email only.

2. Your Profile

Once you're a register member of Shockplay.com you will have access to a "Your Profile" section, where you can update your contact information and add additional personal information voluntarily. You can also at any time delete all of your personal information from our database. Raketspel AB will not share or sell any of the information that could be used to personally identify you. The information you may choose to add in "Your Profile" will be used in aggregate with other member's information to tailor the site to best satisfy member demands and interests.

In addition, we may ask whether you would like to receive information about new Shockplay.com features and promotions. We also sometimes collect information to find out how people found the Shockplay.com site, which pages they visited, and how long they stayed. Or we may ask you for information about your hobbies, game preferences, etc. This information is only requested on a voluntary basis. Raketspel AB may aggregate this demographic information and disclose such information in aggregate to third parties. However, in these situations, Raketspel AB will not share any information that could be used to personally identify you.

3. Why We Collect This Information

There are several reasons to why we collect personally identifiable information:

a. Membership purchase

In order for us to provide you with the Shockpolay.com paid subscription service we require users to give us delivery information and credit card information.

b. Game functionality

Some of our games will require that we know exactly where you are located in the world in order fore us to provide you with a consistent standard of "Game experience".

c. Contest Prizes

We will regularly arrange tournaments and contests where participants can win prizes. In order for us to award the winners their prices we will need to know who they are and where they live.

d. Member Satisfaction

The more we know about our members the more we can customize the site in order to satisfy the demands and wishes of our members.

e. Marketing Purposes

As previously mentioned we will never share, rent or sell any personally identifiable information to a third party, we will however use collected member information as a foundation when selecting which promotions and advertisements we display on the Shockplay.com site and in the Shockplay.com newsletter.

4. When We Collect the Information

Visitors can access Shockplay.com and browse our Web site without disclosing any personal data. However, in order to provide you with a particular product or service online, Raketspel AB may request that you voluntarily supply primary personal data as stated below. Raketspel AB uses a secure transmission method of sending such information.

a. Member Registration

When you register to become a member, Raketspel AB uses an order form. For that order form, we collect a user's contact information plus other information (e.g. a member name, a nickname, and certain user preferences) and necessary financial information to process the order (i.e. credit card number). Contact information from the order is used to send orders to our registered users and to get in touch with the user when deemed necessary. Once you are a registered user you can update your profile and may be able to provide additional preferential information.

b. Special Contests or Promotions

Raketspel AB may occasionally present a special contest or promotion that is sponsored by another company. To qualify for entry in that contest or promotion, we may ask you to provide personal information. If we plan to share that information with the sponsor(s) or with others, we will provide a statement to that effect in the contest or promotion terms.

c. IP Address

An Internet Protocol (IP) address is unique string of numbers that is assigned to your computer by your Internet Service Provider. Web servers automatically identify your computer by its IP address. We will use your IP address to help diagnose problems with our server and to administer our site. Your IP address also may be used to gather broad demographic information.

d. Cookies

Shockplay.com, as well as most sites on the Internet, uses a software technology called "cookies." Cookies are small text files that we place in visitors' computer browsers to store their preferences. Cookies themselves do not contain any personally identifiable information. Although cookies could enable us to relate a visitor's use of this Web site to personal information that a visitor has provided, such as an e-mail address, we do not use them for this purpose. Cookies can help Raketspel AB ensure that we don't serve you the same ad multiple times, and help our advertisers understand what you like and don't like about their offerings so that they can cater better to your needs the next time you are interested in their products or services. Cookies are not required for Raketspel AB to deliver you an ad. If you do not want the benefit of cookies, there is a simple procedure to manually delete your cookies. Please consult your web browser's Help documentation for more information.

5. Third-Party Sites and Sponsors / Links to Other Sites

Our site contains links to other sites, including those of sponsors and advertisers, whose information practices may be different from ours. Sometimes the other sites might conduct contests or sweepstakes that are promoted on Shockplay.com. Visitors should consult the other sites' privacy notices/policies, since those sites are not covered by our privacy policy and may follow procedures that are different from ours. Raketspel AB never gives a user's e-mail address to sponsors without permission, however, if you choose to "opt-in" (click on a box to receive a sponsor's information) or to register with one of our sponsors, that means you have allowed Raketspel AB to give your e-mail address to that sponsor. Raketspel AB may also link to Web sites that feature Shockplay.com trademarks and names along with trademarks and names of other companies. You should look at the privacy policy on that co-branded Web site, as the co-branded Web site may not be under Raketspel AB's control.

5. Who does Raketspel AB share information with?

We will not share your personally identifiable information with third parties (aside from entities that perform services for us, such as fulfilling orders, that either are bound to comply with our privacy policy or have privacy policies that protect your information) unless you have "opted-in" to such sharing. If you have previously opted-in to such sharing under a prior privacy policy version, you are still considered to have opted-in under this Privacy Statement. However, we will disclose information we maintain when required doing so by law, for example, in response to a court order or a subpoena. We also may disclose such information in response to a law enforcement agency's request. We may gather demographic information from you (for example, your age, education level or household income) from time to time. We will not share that information in a manner that identifies you as an individual with any other entity, unless we let you know that at the time of collection or we have your permission. When we share demographic information with third parties, we will give them aggregate information only. As we develop our business, we may buy or sell assets, and, depending upon the transaction, your personal information may be one of the transferred assets. In the event that Shockplay.com is acquired by another company, your personal information may be part of the assets transferred to the acquiring party. In the event of such transfer of assets, we guarantee that your personal information will continue to be treated according to this Privacy policy, and that if any changes will be implemented you will be notified in time to decide whether to remain a member under the new conditions or to remove your information and discontinue membership. Notification of such changes will be made in the Shockplay.com newsletter and on the Shockplay.com web site. Back to top

6. How to control the use of my personally identifiable information

As previously mentioned you will have full control over your personal information in the "My Profile" Section. We will never send you promotions from third parties unless you actively request to have that information e-mailed to you

("opt-in"). If you ever change your mind regarding the information you have opted in to receive, you can discontinue subscriptions or participations at any time by simply clicking the "Unsubscribe" link prominently displayed in every email send out by Raketspel AB.
